Laurence Kwark:

- GSEF (Global Social Economy Forum) is a global Social and Solidarity Economy (SSE) network that aims to serve as a platform for sharing visions and experiences through collaboration and cooperation based on multilateral (publicprivate-collective)

partnerships to build an inclusive, equitable and human-centered world.

- This violent COVID-19 pandemic has triggered not only a health crisis but also a socio-economic crisis in many countries. The COVID-19 pandemic crisis is a problem that we need to respond to together.

- COVID-19 affects the world but not all people in the same way. The socio-economic crisis is accelerating inequalities within and between countries, among the most vulnerable groups, such as women, youth, people with disabilities, indigenous peoples, migrants, marginalized communities, people with precarious employment contracts and the informal economy.

- In addition, the current context results in the loss of 305 million jobs worldwide, according to ILO estimates. We need to work for the transformation of the informal economy by ensuring social inclusion and social protection.

- SSE companies create jobs linked to the social fabric of the community by contributing to the creation and maintenance of decent jobs within the community and necessary services in the territory.

- It is important to rethink our way of doing the economy; to propose the post-COVID-19 socio-economic recovery; how to work for a people-centered economy protecting the planet.

- One aspect that should be considered is the co-creation of public policies with resilience, innovation and cooperation at local, regional and international levels, seeking synergies among all.

- To transform the vision of young people.

Luciano Concheiro Bórquez:

- Approaches to social innovation: democracy worked in depth.

- Appropriation of the space: work of the locality from the locality, to raise it also at the level of the nations and above all to raise it as a new way of being international. That is why this forum is so important now.

- Working together: vital reference. As solidarity and reciprocity especially with vulnerable groups.

- The civilization we have today has been questioned: a new concept of integrality and an interpretation of the relationship with the environment.

- The question of democracy: work it much more thoroughly.

- Territoriality: work of the locality from the locality, it is surprising that we do not raise it at the level of nations, much less in a global crisis.

- A solidarity must occur from a new global form.

- That is why these forums serve to develop this new form and we must work together to achieve it.

- Inclusion, solidarity, well-being, reciprocity as guiding principles.

- Putting vulnerable groups first, since the neoliberal model left them in the end. They must be taken up again.

Nancy Yadira Santiago:

- Searching for new ways to undertake towards the SSE.

- We are living a moment of change in the face of this contingency.

- Society cannot live together in the same way: looking for spaces where people look towards cooperativism and unite collectively to improve their economy: new strategies.

- Boosting the local economy: if we start from the inside, this can give a future to global economies.

- Statistics show that once the pandemic is over, the economy will be greatly affected.

Alexander Schischlik:

- Young people are the most affected by this crisis, in addition to women and the informality of trade.

- It is necessary to involve young people from the beginning, so that they get engaged and committed, that they become partners in the response to the COVID.

- Surely the economy will be different after this.

- The social role that young people play: they must be trained and given tools so that they can be real actors and can identify their role in society.

- The lessons of the SSE are perfectly reflected in the interests of young people: horizontality.
